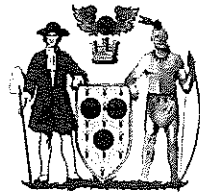
LEGAL NOTICE PUBLIC HEARING PLANNING BOARD VILLAGE OF SCARSDALE

1. The application of Hoff-Barthelson Music School for Site Plan approval, pursuant to Chapter 251 of the Village Code, to install a sign on the Popham Road side of the property which is located at 25 School Lane, identified on the Village tax map as Sec. 1, Blk. 2, Lot 20A.
2. The application of Lynn Jacobs for a Wetlands Permit, pursuant to Chapter 171 of the Village Code, to construct a porch and deck on this wetlands controlled property at 77 Tunstall Road, identified on the Village tax map as Sec. 4, Blk. 4, Lot 388.
